The following project activities were carried out:

- Collecting data on implementation of the Slovenian National digital decade strategic roadmap with focus on measures relating to digital inclusion progress;
- On-line visualization of data collected:
- Creating briefing reports on data assessment and monitoring;
- Organizing on-line workshop for civil society organisations on the National strategic roadmap update;
- Organizing experts panel addressing the governance of the National strategic roadmap;
- Preparing shadow report on National strategic roadmap implementation with proposals to the roadmap update;
- Sending proposals to the National roadmap update to the Ministry of Digital Transformation and presenting them to the European Commission;
- Organizing CSOs press conference presenting shadow report on National strategic roadmap and proposals to the roadmap update;
- Dissemination project results via social media, websites, press release and videos.

Groups targeted and involved in the project activities included: citizens, CSOs, experts, journalists, academics, media, local municipalities, digital transformation stakeholders, government officials, National and EU policymakers.

The main project results

- Proposals for the National digital decade strategic roadmap update prepared as part of civic dialogue process addressing digital inclusion, digital citizenship, digital rights and principles;
- Diversity, Equity, Inclusion and Accessibility principles incorporated into the national roadmap update proposals;
- pilot methodology for gathering data and monitoring public policy measures in the field of digital transformation established;
- the first shadow report on implementation of the National digital decade strategic roadmap created;
- Ministry of digital transformation provided feedback to 11 out of 14 proposals to the

update of the National Strategic Plan for the Digital Decade;

- 6 proposals identified were fully or partially included by the Ministry of digital transformation into the draft Action Plan of the Digital Slovenia 2030 Strategy (updated National Strategic Plan for the Digital Decade) including the principles of technological neutrality and digital sovereignty, external evaluation of the results and impact of digital inclusion actions, the revision of the national baseline for the share of the population with at least basic skills and a corresponding revision of the existing national trajectory for reaching the target of 80% of the population with at least basic digital skills by 2030, support to NGOs policy networks projects in the field of digital competences, update of the guidelines for the development of government IT solutions for the use of open source approaches and open standards and the update of the participation of Slovenia in the implementation of the European Digital Infrastructure Consortium (EDIC) for Digital Commons multi-country project.

Significant project achievements

- Established analytical capacities of NGOs for monitoring digital decade policies;
- Information and open data on digital decade goals organized and available at a national level;
- Improved collaboration among NGOs and academic sector in reflecting national digital policies;
- Possibility to upscale the monitoring of the implementation of National strategic roadmap in other national contexts (Member states);
- Recognition of the project by the European Commission as an example of good practice of civil society in helping with monitoring National roadmap implementation.

Impact on target groups

- Enhanced watchdogging and advocacy collaboration role of NGOs in the field of digital inclusion;
- Better awareness about CSOs positions and efforts relating to an inclusive digital transformation among decision-makers / government officials and other stakeholders;
- Improved understanding, knowledge and awareness about digital policies measures among general population;
- Opportunity created for the Ministry of Digital Transformation to improve measures and actions in National roadmap relating to DEIA principles.

The main lesson learned

Democratic governance at the national level represents a key precondition for an accountable and meaningful progress toward achieving of the European digital decade goals. Currently, there is a significant lack of democratic governance in the area of digital transformation policy-making in Slovenia.
